



BEARFACTS 1996 – 2006

Benton , Iowa [19011]

Benton is one of 99 counties in Iowa. It is part of the [Cedar Rapids, IA \(MSA\)](#). Its 2006 population of 26,576 ranked 23rd in the state.

PER CAPITA PERSONAL INCOME

In 2006 Benton had a per capita personal income (PCPI) of \$29,885. This PCPI ranked 49th in the state and was 90 percent of the state average, \$33,038, and 81 percent of the national average, \$36,714. The 2006 PCPI reflected an increase of 5.4 percent from 2005. The 2005-2006 state change was 4.8 percent and the national change was 5.6 percent. In 1996 the PCPI of Benton was \$21,481 and ranked 52nd in the state. The 1996-2006 average annual growth rate of PCPI was 3.4 percent. The average annual growth rate for the state was 3.9 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Benton had a total personal income (TPI) of \$794,230*. This TPI ranked 25th in the state and accounted for 0.8 percent of the state total. In 1996 the TPI of Benton was \$520,886* and ranked 25th in the state. The 2006 TPI reflected an increase of 5.1 percent from 2005. The 2005-2006 state change was 5.4 percent and the national change was 6.7 percent. The 1996-2006 average annual growth rate of TPI was 4.3 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Benton. In 2006 net earnings accounted for 70.1 percent of TPI (compared with 65.5 in 1996); dividends, interest, and rent were 14.6 percent (compared with 20.9 in 1996); and personal current transfer receipts were 15.3 percent (compared with 13.6 in 1996). From 2005 to 2006 net earnings increased 3.8 percent; dividends, interest, and rent increased 6.2 percent; and personal current transfer receipts increased 10.0 percent. From 1996 to 2006 net earnings increased on average 5.0 percent each year; dividends, interest, and rent increased on average 0.6 percent; and personal current transfer receipts increased on average 5.5 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Benton increased from \$284,222* in 2005 to \$293,079* in 2006, an increase of 3.1 percent. The 2005-2006 state change was 4.1 percent and the national change was 5.7 percent. The average annual growth rate from the 1996 estimate of \$204,363* to the 2006 estimate was 3.7 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 5.5 percent.
