

BEARFACTS 1995 – 2005

Fremont , Iowa [19071]

Fremont is one of 99 counties in Iowa. It is not part of a Metropolitan Area. Its 2005 population of 7,698 ranked 92nd in the state.

PER CAPITA PERSONAL INCOME

In 2005 Fremont had a per capita personal income (PCPI) of \$30,066. This PCPI ranked 32nd in the state and was 95 percent of the state average, \$31,670, and 87 percent of the national average, \$34,471. The 2005 PCPI reflected a decrease of 1.9 percent from 2004. The 2004-2005 state change was 2.5 percent and the national change was 4.2 percent. In 1995 the PCPI of Fremont was \$18,469 and ranked 68th in the state. The 1995-2005 average annual growth rate of PCPI was 5.0 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2005 Fremont had a total personal income (TPI) of \$231,447*. This TPI ranked 84th in the state and accounted for 0.2 percent of the state total. In 1995 the TPI of Fremont was \$150,926* and ranked 87th in the state. The 2005 TPI reflected a decrease of 2.4 percent from 2004. The 2004-2005 state change was 2.9 percent and the national change was 5.2 percent. The 1995-2005 average annual growth rate of TPI was 4.4 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Fremont. In 2005 net earnings accounted for 62.2 percent of TPI (compared with 55.0 in 1995); dividends, interest, and rent were 19.3 percent (compared with 23.9 in 1995); and personal current transfer receipts were 18.5 percent (compared with 21.1 in 1995). From 2004 to 2005 net earnings decreased 5.1 percent; dividends, interest, and rent increased 0.6 percent; and personal current transfer receipts increased 4.4 percent. From 1995 to 2005 net earnings increased on average 5.7 percent each year; dividends, interest, and rent increased on average 2.2 percent; and personal current transfer receipts increased on average 3.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Fremont decreased from \$172,547* in 2004 to \$164,166* in 2005, a decrease of 4.9 percent. The 2004-2005 state change was 3.2 percent and the national change was 5.6 percent. The average annual growth rate from the 1995 estimate of \$109,708* to the 2005 estimate was 4.1 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.5 percent.
