

## **BEARFACTS 1995 – 2005 Greene , Iowa [19073]**

Greene is one of 99 counties in Iowa. It is not part of a Metropolitan Area. Its 2005 population of 9,962 ranked 79th in the state.

### **PER CAPITA PERSONAL INCOME**

In 2005 Greene had a per capita personal income (PCPI) of \$27,877. This PCPI ranked 63rd in the state and was 88 percent of the state average, \$31,670, and 81 percent of the national average, \$34,471. The 2005 PCPI reflected a decrease of 0.6 percent from 2004. The 2004-2005 state change was 2.5 percent and the national change was 4.2 percent. In 1995 the PCPI of Greene was \$20,079 and ranked 32nd in the state. The 1995-2005 average annual growth rate of PCPI was 3.3 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.1 percent.

### **TOTAL PERSONAL INCOME**

In 2005 Greene had a total personal income (TPI) of \$277,707\*. This TPI ranked 80th in the state and accounted for 0.3 percent of the state total. In 1995 the TPI of Greene was \$205,326\* and ranked 78th in the state. The 2005 TPI reflected a decrease of 1.7 percent from 2004. The 2004-2005 state change was 2.9 percent and the national change was 5.2 percent. The 1995-2005 average annual growth rate of TPI was 3.1 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 5.2 percent.

### **COMPONENTS OF TOTAL PERSONAL INCOME**

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Greene. In 2005 net earnings accounted for 56.8 percent of TPI (compared with 56.3 in 1995); dividends, interest, and rent were 23.8 percent (compared with 25.1 in 1995); and personal current transfer receipts were 19.4 percent (compared with 18.6 in 1995). From 2004 to 2005 net earnings decreased 5.5 percent; dividends, interest, and rent increased 3.1 percent; and personal current transfer receipts increased 4.5 percent. From 1995 to 2005 net earnings increased on average 3.2 percent each year; dividends, interest, and rent increased on average 2.5 percent; and personal current transfer receipts increased on average 3.5 percent.

### **EARNINGS BY PLACE OF WORK**

Earnings of persons employed in Greene decreased from \$157,146\* in 2004 to \$146,124\* in 2005, a decrease of 7.0 percent. The 2004-2005 state change was 3.2 percent and the national change was 5.6 percent. The average annual growth rate from the 1995 estimate of \$115,078\* to the 2005 estimate was 2.4 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.5 percent.
