



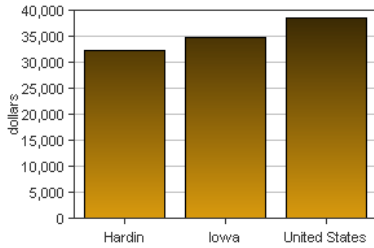
Hardin, Iowa

Hardin is one of 99 counties in Iowa. It is not part of a Metropolitan Area. Its 2007 population of 17,473 ranked 41st in the state.

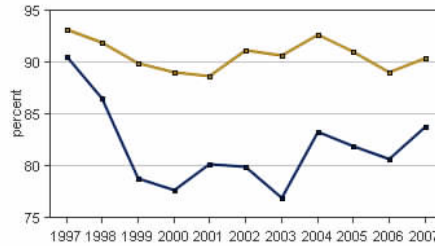
PER CAPITA PERSONAL INCOME

In 2007 Hardin had a per capita personal income (PCPI) of \$32,377. This PCPI ranked 53rd in the state and was 93 percent of the state average, \$34,916, and 84 percent of the national average, \$38,615. The 2007 PCPI reflected an increase of 9.1 percent from 2006. The 2006-2007 state change was 6.6 percent and the national change was 4.9 percent. In 1997 the PCPI of Hardin was \$22,946 and ranked 35th in the state. The 1997-2007 average annual growth rate of PCPI was 3.5 percent. The average annual growth rate for the state was 4.0 percent and for the nation was 4.3 percent.

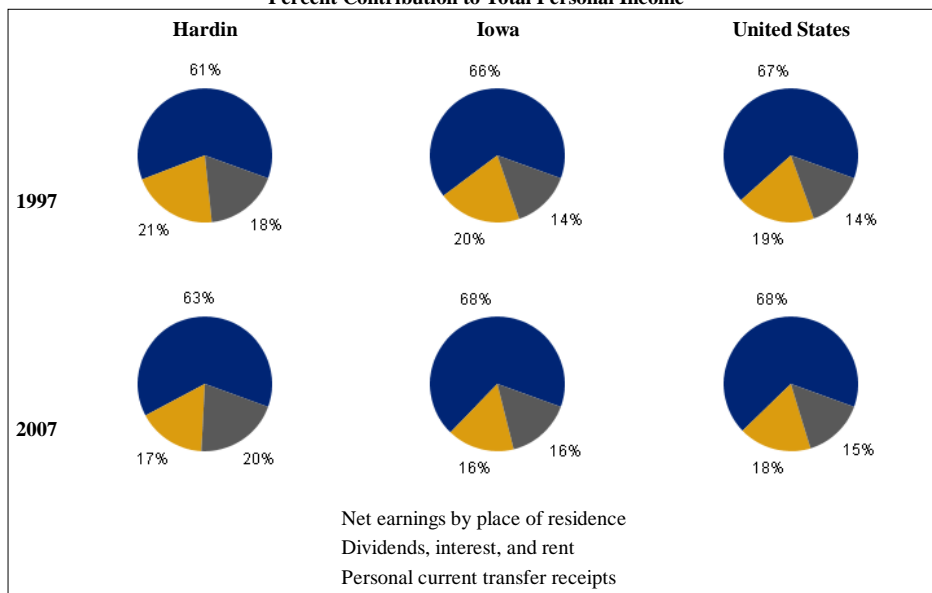
In 2007 Hardin had a total personal income (TPI) of \$565,732*. This TPI ranked 42nd in the state and accounted for 0.5 percent of the state total. In 1997 the TPI of Hardin was \$435,543* and ranked 36th in the state.

*Note: Total personal income estimates are in thousands of dollars, not adjusted for inflation.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Hardin.
