

## **BEARFACTS 1995 – 2005 Winneshiek , Iowa [19191]**

Winneshiek is one of 99 counties in Iowa. It is not part of a Metropolitan Area. Its 2005 population of 21,224 ranked 29th in the state.

### **PER CAPITA PERSONAL INCOME**

In 2005 Winneshiek had a per capita personal income (PCPI) of \$31,150. This PCPI ranked 21st in the state and was 98 percent of the state average, \$31,670, and 90 percent of the national average, \$34,471. The 2005 PCPI reflected an increase of 1.1 percent from 2004. The 2004-2005 state change was 2.5 percent and the national change was 4.2 percent. In 1995 the PCPI of Winneshiek was \$18,183 and ranked 75th in the state. The 1995-2005 average annual growth rate of PCPI was 5.5 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.1 percent.

### **TOTAL PERSONAL INCOME**

In 2005 Winneshiek had a total personal income (TPI) of \$661,117\*. This TPI ranked 27th in the state and accounted for 0.7 percent of the state total. In 1995 the TPI of Winneshiek was \$383,916\* and ranked 33rd in the state. The 2005 TPI reflected an increase of 1.3 percent from 2004. The 2004-2005 state change was 2.9 percent and the national change was 5.2 percent. The 1995-2005 average annual growth rate of TPI was 5.6 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 5.2 percent.

### **COMPONENTS OF TOTAL PERSONAL INCOME**

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Winneshiek. In 2005 net earnings accounted for 66.8 percent of TPI (compared with 64.9 in 1995); dividends, interest, and rent were 19.3 percent (compared with 20.9 in 1995); and personal current transfer receipts were 13.9 percent (compared with 14.2 in 1995). From 2004 to 2005 net earnings increased 0.8 percent; dividends, interest, and rent decreased 0.5 percent; and personal current transfer receipts increased 6.3 percent. From 1995 to 2005 net earnings increased on average 5.9 percent each year; dividends, interest, and rent increased on average 4.7 percent; and personal current transfer receipts increased on average 5.4 percent.

### **EARNINGS BY PLACE OF WORK**

Earnings of persons employed in Winneshiek increased from \$492,688\* in 2004 to \$498,845\* in 2005, an increase of 1.2 percent. The 2004-2005 state change was 3.2 percent and the national change was 5.6 percent. The average annual growth rate from the 1995 estimate of \$280,279\* to the 2005 estimate was 5.9 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.5 percent.
